Ceilings -

A crack in the Utility Room at the back wall area
In the guest bathroom a small spot of decorative plaster was knocked off when the sink faucet broke.

Doors -

The door to the back bedroom will not stay completely open

Electrical Systems -

The electric wire that goes to the RV Area is not in conduit. It does run part of the way along side the water line.

Exterior Walls -

There are several small holes in the siding and skirting in various places.

Foundation/Slab -

There are a few cracked support bricks.

Interiors Walls -

Cracks in walls: ① Master bedroom at floor between window and end wall. ② Living Room at floor between window and bedroom wall. ③ Back bedroom at floor under window.

The Utility Room has some water damage area due to the AC unit not draining properly at one time (the issue was fixed). In the same area, the water line at the washer broke. The water was immediately turned off, and the area dried.

In the guest bathroom, the original faucet broke.

There is slight water damage to the doorway area and the cabinet.

Plumbing Systems:

There are compression joints on the water line from the meter to the house. These are from previous water line breaks, approximately 4-5 on the line.

The water line going to the RV spot has been capped off.

Windows:

All windows open and shut, however some are slightly harder than others ① Dining Room ② Master bedroom

③ Living Room.

Additionally, the frame on one living room window was repaired. Due to this repair, the inside window lacks about $\frac{1}{8}$ inch from closing on that side.

The outside window shuts completely so there are no weather related issues.

Additional Information on Appliances:

The GE Refrigerator works as it should. It does have a habit of making "odd" sounds on occasion. These are similar to squealing and groaning. The sounds are sporadic. It has made them for as long as we have had it and has not affected its ability to function correctly.

Floors:

There is a small area of carpet in the living room where the carpet pile fibers are missing.

At the doorway to the back bedroom a wooden threshold covers a hole in the carpet.
